Similarly, Aadhaar needs to be updated with latest photo and latest biometrics (Fingerprint & Iris) before filling the online application.
- This notification is purely indicative in nature issued solely for the purpose of keeping prospective candidates informed about the forthcoming CEN and to be in readiness with necessary certificates and documents required for applying.
